Background & Purpose

On August 4, 2025, Governor Mike Dunleavy issued Administrative Order 360 directing state agencies to review and improve regulations to ensure they are clear, current, and reduce unnecessary burdens while continuing to support schools, districts, and families.



Phase 1 – Framework & Baseline August 2025 through January 2026

- Appoint Agency Regulatory Liaison (ARL): Appoint an Agency Regulatory Liaison (ARL) to oversee the department's regulatory review.
- Training & Guidance: Receive training and templates from the Department of Law to ensure consistency across departments.
- Stakeholder Engagement: Conduct stakeholder meetings to gather public input.
- Baseline Establishment: Calculate and submit the total number of discretionary requirements to establish the baseline.
- Initial Reform Plan: Submit proposed reform plans by January 2026 identifying which regulations will be reduced or streamlined.
- Transparency: Post guidance documents and reform plans publicly to ensure transparency.
- Deliverable: Publish an approved framework with the established regulatory baseline and initial reform plan.



Phase 2 – 15 Percent Reduction of Regulations Calendar Year 2026

- Target: Achieve a 15 percent reduction in discretionary regulatory requirements from the established baseline.
- Implementation: Begin regulatory revisions based on stakeholder feedback.
- Progress Reporting: Submit quarterly progress reports to the Governor's Office and Department of Law documenting reductions, additions, and overall progress.
- Stakeholder Feedback Integration: Document how public recommendations were accepted or rejected.
- Unified Regulatory Plan: Contribute to the annual statewide plan showing progress and upcoming rulemaking.
- Deliverable: Verify and document achievement of the 15 percent reduction milestone.



Phase 3 – 25 Percent Reduction of Regulations Calendar Year 2027

- Target: Achieve a 25 percent cumulative reduction from the established baseline.
- Deep Reform: Address complex regulatory burdens by streamlining processes, digitizing workflows, and reducing duplicative requirements.
- Continuous Review: Incorporate newly added regulations into the baseline and adjust reductions to maintain the 25 percent goal.
- Reporting: Continue submitting quarterly reports tracking cumulative progress.
- Transparency and Publication: Post updated regulatory reform plans publicly and ensure all guidance documents are reviewed and validated by the Department of Law.
- Deliverable: Verify and document achievement of the 25 percent reduction milestone, ensuring long-term efficiency, transparency, and compliance.



Next Steps: Stakeholder Engagement

- DEED is conducting virtual stakeholder meetings via Zoom from October 2 through December 18, 2025.
- For each regulation chapter, DEED will host two meetings (8:00 a.m. and 4:00 p.m.).
- Participants may submit written or oral feedback for consideration.
- This process is intended to incorporate stakeholder input before developing any proposed regulatory amendments.
