Renewal Application for WIDA Domain Exemption

Candidates for a domain exemption on WIDA ACCESS/WIDA Screener are English learners with a documented disability that does not allow them to engage with the domain, even with available accommodations. In determining which student situation might be eligible for a domain exemption, administrators and teachers must determine that the **student meets all three** of the following criteria:

- The student has a documented disability or impairment (IEP or 504) applicable to the domain;
- Even with available accommodations, the student cannot engage with (access) the domain; and
- The 504 plan or IEP team, in consultation with the educator(s) supporting student's English language development, have established a need for a domain exemption.

It is essential that the team include participants who have the requisite knowledge of the child's English language development needs. The determination must be documented in the student's plan.

Directions: This application is for students who were approved for a domain exemption in the previous year and who the district believe still qualify in the current school year.
